INSTRUCTIONS ANNEX FOR THE MS-3B FORM

1. USAGE:

1.1. The MS-3B form is to be used when removing an individual from the S.I Moderation Service.

2. AUTHENTICATION, APPLICATION & COPIES:

- 2.1. This form is considered 'authenticated' only when all fields are properly filled in, as applicable, by a person authorised to fill in the form.
- 2.2. People authorised to fill in this form in an official capacity is as follows:
 - (a) SLT personnel,
 - (b) MS-LT personnel,
 - (c) moderators at, or above the grade of Administrative Officer,
- (d) any person authorised by the above to act on their behalf (MUST BE NOTED IN 'REMARKS').

 2.3. The person entering the document into the SI Document archive MUST ensure the authenticity of the A.O.
- 2.4. This form is considered 'applicable' when the form is entered into the SI Document archive, pursuant to the above requirements.
- 2.5. Copies of the form must be sent to, or placed in the following locations:
 - (a) the SI Document Archive at "Forms/Moderation-Service/Series-3/Category-B",
 - (b) the SI Document Archive at "Records/Personnel/Staff-ID-<Staff ID>",
 - (c) the effected moderator's line manager,
 - (d) the effected moderator, if requested.
- 2.6. The title of this document should follow the format:

- 2.7. The document can be entered as either a PDF, JPEG or PNG. If originally filed as a non PDF, it should be converted to PDF format with OCR enabled.
- 2.8. The Instructions Annex does not need to remain attached to the document.

3. NOTES:

- 3.1. This form does not remove an individual from Spearhead Industries as a whole; a separate PS-1B form should be filed.
- 3.2. If the user is an 'external moderator' (a moderator who only works within an external C.M.T), no further forms are required for successful removal.
